## 2. Reason for the change

The pachinko and pachislot industry, in which the Group operates, is facing a challenging environment. Amid ongoing declines in the player population and the number of pachinko parlors, the Great East Japan Earthquake evoked criticisms of the pachinko and pachislot industry. On the other hand, in line with the progress of visual, audio and figurine technologies, game machines have become established as a socially and economically influential media. The Group's *Evangelion* series is a major example. In recent years, game machines have started to incorporate functions of social networking services via mobile phones and are rapidly becoming entertainment platforms involving wide-ranging industries.

In these circumstances, the Group considers it is necessary for the pachinko and pachislot industry, including parlor operators and manufacturers, to work in concert to expand the scope of the industry and enhance the relationship with society. There is a need to facilitate collaboration with other industries to create products that earn the confidence of players and parlor operators. Moreover, it is necessary to enhance corporate value through business growth. Not only the Group's growth but also the industry's growth must be achieved. In order to ensure growth, the board of directors concluded that the Group should go forward under new leadership from April 2012 onward.

Mr. Kimihisa Tsutsui, who will be appointed the president and COO on April 1, 2012, has been involved in corporate planning since he joined SANKYO. While engaged in tasks related to management of the entire business, including the Company's stock listing, establishment of a business model, organization management, and alliances with external parties, Mr. Tsutsui has been responsible for communication with mass media, analysts, and investors, as the Group's spokesman and IR manager. He will strive to achieve growth of the Group and the industry while continuing collaboration with diverse stakeholders, representing various organizations and industries, and responding to change in the environment in which the Group and the industry operate.
